PROMOTION REGULATIONS CONCERNING THE PURCHASE OF TOKENS VALID UNTIL 09 JANUARY 2022

1. Organizer of the promotion.

The Organizer of the promotion is **CCFOUND Sp. z o.o. Sp. K.** with its seat in Wrocław 50-203 at Dmowskiego Street 3/9, registered in the District Court for Wrocław-Fabryczna in Wrocław, 6th Commercial Division of the National Court Register, under the KRS number: 0000841288, NIP: 8982257666, REGON: 386055341, hereinafter **CCFOUND**.

2. Legal regulation of promotion.

2.1. The legal basis for the promotion is these Regulations, which is also the only document defining the rules of the promotion. The content of the Regulations is available on the website <u>https://shop.ccfound.com/</u>.

2.2. The promotion is related to the token distribution process, the rules of which are set out in the Token Distribution Rule and the Provision of Services by Electronic Means available on the website https://shop.ccfound.com/, and the definitions used there are applicable in these Regulations.

2.3. Participation in the promotion is voluntary.

3. Subject, duration and place of the promotion.

3.1. The promotion applies to the purchase of Tokens by Users at a discount depending on the position in the Users' ranking in individual Investment Rounds.

3.2. In each Investment Round, CCFOUND publishes in the transaction system, in real time, a ranking of Users purchasing the Tokens of the highest value.

3.3. The amount of the discount is as follows:

Places in the ranking 1-3 entitle you to purchase Tokens in the next Investment Round at a discount of 50% of the investment value from the last Investment Round;

Places in the ranking 4-7 entitle you to purchase Tokens in the next Investment Round at a discount of 40% of the investment value from the last Investment Round;

Places in the ranking 8-10 entitle you to purchase Tokens in the next Investment Round at a discount of 30% of the investment value from the last Investment Round;

Places in the ranking 11-100 entitle you to purchase Tokens in the next Investment Round at a discount of 5% of the investment value from the last Investment Round.

3.4. With each subsequent Investment Round, the discount value for the first 10 places will decrease by 5 percentage points.

3.5. During the first Investment Round lasting from 09 August to 22 August 2021, the first ranking of Users will be published and at its end, Users will be selected who will be eligible for a discount in the next Investment Round. The purchase of Tokens at a discount will be possible starting from the second Investment Round lasting from 23 August to 5 September 2021 and in each subsequent round until the last Investment Round covered by the promotion lasting from 27 December 2021 to 9 January 2022.

3.6. The promotion runs from 09 August 2021 to 09 January 2022.

3.7. The promotion is run in the CCFOUND transaction system on the website <u>https://shop.ccfound.com/</u>.

3.8. CCFOUND has the right to shorten or cancel the promotion period without giving any reason by posting a written 7 days' notice on the website <u>https://shop.ccfound.com/</u>. The

change or cancellation of the promotion period has no effect on acquired rights – that is discounts acquired before the change or cancellation.

4. Promotion rules.

4.1. A participant in the promotion may be a User who accepts these Regulations.

4.2. The promotion consists in the possibility of receiving a discount for the purchase of Tokens in the next Investment Round. The amount depends on the position in the Users' ranking in the preceding Investment Round.

4.3. The user participating in the promotion and entitled to a discount may only use it in the next Investment Round following the Round in which he acquired the right to the discount. The discount is granted automatically in the transaction system.

4.4. This promotion cannot be combined with any other promotion.

5. Final provisions.

5.1. These Regulations are valid from 09 August 2021 to 09 January 2022.

5.2. In matters not regulated, the relevant provisions of the Civil Code shall apply.

5.3. These Regulations are the only authentic document regulating the rules of the promotion.

5.4. In the event of a conflict of the provisions of these Regulations with the mandatory provisions, the provisions of the mandatory provisions shall apply in place of these provisions.
